IELP/Undergraduate Refund Policy

1. *The \$250.00 IELP Tuition Deposit will be refunded if the applicant is not admissible to undergraduate study.
2. The \$100.00 admissions assessment fee and \$25.00 courier fee are non-refundable.
3. If a Study Permit is denied, and the applicant does not wish to defer to the next IELP session, there will be no refund of fees.

IELP/Undergraduate Deferral Policy

1. If a change in IELP starting date is requested by the applicant (for whatever reason including Study Permit denial), a \$100 Fee (CANADIAN FUNDS ONLY) payable to Brock University, will be required (fee will not be taken from tuition deposit). Acceptable forms of payment are: Credit Card, Money Order or Bank Draft. Applicant must also send the completed Deferral Request Form available on website.
2. Deferrals will be granted to the next IELP session only, and only granted once. **If a student fails to show for the deferred session, all fees will be forfeited and your Conditional Offer is VOID.**
3. Deferrals must be made before the response date on the response form for the \$250 IELP deposit to be transferred to the next session.
4. **NOTE:** Your Conditional Offer will become VOID if you are absent for more than one IELP session after your studies have begun.
