TUITION AND RELATED FEES FOR FALL/WINTER 2008-09

As permitted and defined by the Ontario government's 2006 tuition fee policy, Brock University assesses differentiated fees between: (a) first and continuing program year of study and (b) "arts & science and other undergraduate programs" and "professional undergraduate and graduate programs" and (c) International (Visa)

Definitions of Year of Study:

Year 1 - are Full or Part time Domestic students who entered the University in 2008 as well as Part-time Domestic students who entered in 2007

Year 2 Continuing - are Full time Domestic students who entered the University in 2007

Upper Years Continuing - are Full or Part time Domestic students who entered the University prior to 2007

The fee information is provided for illustrative purposes for typical situations. The actual fees assessed may vary from these schedules.

FIRST DRAFT FEE

MA, MSc, MBE and PhD Graduate Programs:

Full-time and part-time students (Domestic and Visa) who have completed all course work and have submitted the first draft of their major essay or thesis will pay **\$295.72 per term**. The thesis or major paper must be completed within the academic term for which the first draft fee is assessed.

CONTINUOUS REGISTRATION FEE

Master of Education Courses- EDUC 5F95,5P90,5P93 (project or thesis course):

A fee of **\$295.72 per term** will be charged to all full-time and part-time students (Domestic or Visa) for each term registered in the above noted courses following the initial registration in these courses.

GRADUATE INTERNATIONAL COHORT PROGRAMS

For Graduate International Cohort programs the tuition is charged on a **program basis** and the fees are quoted in Canadian funds. Note all applicable ancillary fees will apply for each registered term in addition to the program fee.
