## Comments 2021:

Chair met with Office of Institutional Analysis (OIA) in February, 2021. The recommended action is feasible and can be done during the 2021 calendar year. **Comments 2023:** Actions #2-4 are completed and/or ongoing. Changes have been made to the curriculum in order to increase academic performance and retention (e.g., replacing BIOL 1P92 with PHYS 1P91 in year 1).

The Department should revisit the Curriculum Mapping exercise with a goal of exploring and reviewing more fully the course level learning outcomes with an emphasis on the upper years.

# Comments 2021:

Curriculum committee has discussed this action throughout the 2020-21 year. One upper year elective (KINE 4P20) has been approved to launch in 2021-22 and two other upper year electives that have not been offered in recent years (KINE 3P65, KINE 3P41) will be offered in 2021-22.

#### Comments 2022:

Three upper year electives (KINE 3P41, 3P65, 4P20) have been offered in 2021-22. Discussion of recoding some existing core courses as electives continues. At least one course has already been recoded (KINE 3P90).

## Comments 2023:

During the 2022 retreat, the curriculum committee led the discussion on the upper-year coreelective balance. The 2022 UPC submission finalized the recording of existing core courses as electives (e.g., KINE 3P90). A new upper-year elective course has been added (KINE 4P09).

## Comments 2023:

KSA continues to organize successful events (e.g., research showcase, *TRIVIA night*) with faculty participation. They continue to meet with their Faculty Coordinator (Dr. Shawn Beaudette) to discuss and organize additional initiatives. The faculty lunchroom has been upgraded. A number of social events for faculty and graduate students were launched in 2022 (e.g., bowling night, and Christmas dinner). Other social gatherings for faculty include *Friday at Issacs* which takes place on the last Friday of each month.
