In 2022-23, the Centre organized two talks as part of the MARS Speaker Series, and had one invited speaker from Montreal. All events were open to the public. They were promoted through the usual university channels, and invitations were extended to community partners. The Centre also collaborated with the MARS student club on several occasions (including an Archive Crawl) to offer the Brock community further exposure to pre-modern documents. A photo shoot coordinated by the Strategic Initiatives and Outreach Officer in the Faculty of Humanities is planned for March 2023 in Archives and Special Collections to provide high quality images that will be used for promotion.

The Centre is committed to nurturing existing and new links with local museums and collections housing pre-modern material. Several MARS courses (such as MARS 4P01 Sources and Methods of Medieval and Renaissance Studies) include visits to Archives and Special Collections and/or the Concordia Lutheran Seminary at Brock University.

Field trips to off-campus locations have not occurred this year due to the temporary closure of some sites and lack of temporary exhibits on pre-modern material.
